



PROFESSIONAL LICENSURE AND CERTIFICATION REQUIREMENTS

Bachelor of Design with concentration in Interior Design

Several programs offered at Universidad Ana G. Méndez – Gurabo Campus are designed to meet the educational requirements to obtain a professional license or certification, mandatory by state law in order for a university graduate to be employed in a specific occupation. The following disclosure contains information about the US jurisdictions for which the program in reference is designed to meet the educational requirements for a specific license or certification.

Requirements for professional licensure and certification vary from state to state, and prospective students are responsible for understanding the requirements in the state in which they plan to work after graduation. UAGM does not guarantee that a student will obtain licensure, certification or employment. Please note that the following information relates only to the educational requirements for the licenses and certifications listed below and is specific to the institution/campus stated above. Other requirements and prerequisites may apply to these licenses and certifications, such as that an applicant successfully complete a criminal record check or other background screenings.

The **Bachelor of Design with concentration in Interior Design** offered at UAGM Gurabo Campus and/or its locations, is designed to meet the educational requirements to apply for the exam required to obtain the license issued by *Junta Examinadora de Diseñadores- Decoradores de Interiores* (Board of Examiners of Designers-Interior Decorators).

The institution has determined that its curriculum **meets** the educational requirements for state licensure or certification required for employment as an **interior designer-decorator** in Puerto Rico and the following US jurisdictions (additional requirements may exist):

Alabama, Connecticut, District of Columbia, Florida, Illinois, Indiana, Iowa, Kentucky, Maryland, Texas, Utah and Wisconsin.

The institution has determined that its curriculum **does not meet** the educational requirements for state licensure or certification required for employment as an interior **interior designer-decorator** in the following US jurisdictions that require programmatic accreditation:

Arkansas, California, Georgia, Louisiana, Maine, Minnesota. Mississippi, Missouri, Nevada, New Jersey, New Mexico, New York, Oklahoma, Tennessee and Virginia.

The University **has not made a determination** whether its curriculum meets the state educational requirements for licensure or certification required for employment as an **interior designer-decorator** in the following US jurisdictions (visit <https://www.cidq.org/jurisdictional-requirements> for further information):
